

REGULAR MEETING - WOLCOTT TOWN BOARD - AUGUST 20, 2013

A regular meeting of the Wolcott Town Board was held Tues., Aug. 20, 2013, at 6:00 PM at the Wolcott Town Hall with the following people present:

Code Enforcement Officer, Don Camp, presented Special Permit Request #8-2013, which was brought before the Town Board on July 18, 2013, at which time a negative impact was declared on the environment and signed by the Supervisor.

It was then taken to the County Planning Board for review and brought back to our Planning Board on August 5, 2013. Request regarding Town of Wolcott Local Law #1-2000 Sections 501-A and 501-C, to construct a 40' x 48' repair garage in an agricultural district.

Don reported that the County recommended disapproval of the re-quest as they did not have a detailed sketch of precisely where he was going to place the repair garage on his property.

SPECIAL PERMIT REQUEST - (cont'd)

Don then stated the local Planning Board, upon their review, was able to see a detailed sketch as to where it was to be located and they approved the request.

There being no objections from the Town Board, the following resolution was presented by Kim Park, moved by Dallas Youngman, sec-onded by Jeff Keller "Be it RESOLVED that the Wolcott Town Board ap-proves the request of Gregg Weeks and the recommendation of the local Planning Board to the Town Board."

ENER-PATH (ENERGY EFFICIENCY PROGRAM) - Rep. Eric Burke

Mr. Burke appeared before the Town Board tonight to present a program through RG&E concerning updating the interior lighting sys-tem at the highway garage. This program would phase out the bigger lights and replace them with more energy efficient ones. Mr. Burke gave each board member a summary of the costs associated with this program, of which RG&E would be paying a little over 50 percent, and proceeded to give them more details about the program. coming and told him to get in touch with Scott regarding their decision. Mr. Burke left at 6:15 PM.
