RESOLUTION #54-12 AUTHORIZING TRANSFER OF \$80,896.51 FROM CAPI-TAL BUILDING PROJECT CD TO GENERAL FUND LINE ITEM A1992.4 FOR REIM-BURSEMENTS FOR RENOVATIONS -

Bookkeeper -

WHEREAS, the Highway Department is in need of a new loader and corresponding agreement; and

WHEREAS, Milton Cat has submitted the most competitive bid and agreement meeting the needs of the Highway Department;

NOW, THEREFORE, BE IT RESOLVED, the Highway Superintendent is authorized to sign agreement with Milton Cat for a 2012 Caterpillar 938K wheel loader for a cost of \$8,800.00.

3. Scott reported the road they have been working on should be finished up this week.

CODE ENFORCEMENT OFFICER - Don Camp

SPECIAL PERMIT REQUEST - Gary Walczak 7792 Dove Rd. Wolcott, NY 14590 Tax Map #75119-11-702522

Code Enforcement Officer, Don Camp, presented Special Permit Request #2-2012, which was brought before our Town Board August 21, 2012, at which time a negative impact was declared on the environ-ment and signed by the Supervisor. Then it was taken to the County Planning Board for review and brought back to our Planning Board on Sept. 11, 2012. Request regarding Town of Wolcott Local Law #2-2000, Section 502-C, construct 12' x 24' addition to his cottage in a waterfront district. Don explained that the County Planning Board approved it as well as our local Planning Board. He stated adjoining properties were informed of the project and he didn't receive any comments either way.

There being no objections from the Town Board, the following resolution was presented by Kim Park, moved by Dallas Youngman, seconded by Jeff Keller "Be it RESOLVED that the Wolcott Town Board approve the request of Gary Walczak and the recommendation of the Planning Board to the Town Board."

TOWN CLERK - Dawn Krul

1. The Town Clerk reported last month she wanted to have a dog enumeration done this fall but due to the renovation project will wait until the spring to have Gary do one.

2. The Town Clerk asked about paying the custodian extra for washing the windows. In the past it was a set amount, but the Board wanted to know how many hours it took her to do them. The Town Clerk will find out and get back to the Board.

SUPERVISOR - Kim Park

1. Kim updated the rest of the Board on the Blind Sodus Bay Sewer Project and addressed some of the reasons for the holdup in funding for this project. She asked Amber and Don to comment on

the roles they play in this project as Assessor and Code Enforce-ment. Discussion.

2. Kim had a phone call from a resident on Brown Road who would like to see a speed limit sign posted. She asked the Highway Supt. to look into getting a sign posted.

3. Kim said Ken Applin, who's company takes care of

monitoring our former landfill, asked about having it mowed as it has grown up so much it inhibits what they need to do. Kim will have him contact the Highway Supt. to work something out.

4. Kim once again updated the rest of the Board on the renova-tions that have been done to the front half of the Town Hall. We now have foam insulation, central heat/air, and an updated phone system just to mention a few. Kim asked Chris Loveless to comment on any-thing he wanted to add.

5. Kim brought to the table the need to resolve some personnel issues with our local Planning Board. Discussion.

WHEREAS, the current chair of the Planning Board has missed all consecutive meetings since January of 2012, making it extremely difficult to conduct town Planning Board business;

NOW, THEREFORE, BE IT RESOLVED, the Town Board removes Joe Gallo from the town Planning Board due to consecutive absences.

COURT CLERK - Mary Anne McConkey

Mary Anne attended tonight's meeting to discuss the

salaries of the court personnel for the 2013 budget. Mary Anne submitted a let-ter to Board members and it was accepted as correspondence earlier

in tonight's meeting. The letter requested that the Board consider increasing her and the justices salaries more than the suggested 2 percent and gave details to support her specific request. Discus-sion ensued with comments and/or questions between the Board and

Mary Anne. At the end of the discussion, Supervisor Park said she would get a salary comparison sheet containing other court clerk's and justices salaries in the county to the board members so they could go over them before the upcoming budget workshop.
